#### 2. HAZARDS IDENTIFICATION

# **Emergency Overview:**

Appearance and Odor: Off-white powder with a slight odor.

**Warning Statements:** Keep out of reach of children. CAUTION. Harmful if swallowed, inhaled, or absorbed through skin. Causes eye irritation. Avoid contact with skin, eyes, or clothing. Avoid breathing dust or vapor.

## **Potential Health Effects:**

Likely Routes of Exposure: Inhalation, eye and skin contact

Eye Contact: Mildly irritating based on toxicity studies.

**Skin Contact:** Mildly toxic and slightly irritating based on toxicity studies.

**Ingestion:** Moderately toxic based on toxicity studies.

Inhalation: Low inhalation toxicity based on toxicity studies.

#### 4. FIRST AID MEASURES

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If on Skin:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**Note to Physician:** No specific antidote is available. Treat the patient symptomatically.

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

**Environmental Precautions:** Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

**Methods for Containment:** Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

#### 7. HANDLING AND STORAGE

## Handling:

Avoid contact with skin, eyes, or clothing. Avoid breathing dust or vapor. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment

(PPE) immediately after handling this product. Wash outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

### Storage:

Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizer, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area. Do not contaminate water, food, or feed by storage or disposal. For water-soluble packaging, exposure to moisture or excessive handling of water-soluble packets may cause breakage.

## **Engineering Controls:**

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

## **Personal Protective Equipment:**

**Eye/Face Protection:** To avoid contact with eyes, wear chemical goggles or shielded safety glasses. An emergency eyewash or water supply should be readily accessible to the work area.

**Skin Protection:** To avoid contact with skin, wear long-sleeved shirt and long pants, shoes, socks, and chemical-resistant gloves made of waterproof material. An emergency shower or water supply should be readily accessible to the work area.

**Respiratory Protection:** Not normally required. If vapors or mists exceed acceptable levels, wear NIOSH approved air-purifying respirator with cartridges/canisters approved for use against pesticides.

# 10. STABILITY AND REACTIVITY

**Chemical Stability:** This material is stable under normal handling and storage conditions.

Conditions to Avoid: Excessive heat. For imidacloprid, strong exothermal reaction above 200°C.

Incompatible Materials: Not known

# 11. TOXICOLOGICAL INFORMATION

## **Toxicological Data:**

Data from laboratory studies conducted on a similar, but not identical, formulation:

**Oral:** Rat LD<sub>50</sub>: 2,200 mg/kg **Dermal:** Rat LD<sub>50</sub>: >2,000 mg/kg **Inhalation:** Rat 4-hr LC<sub>50</sub>: >2.5 mg/L **Eye Irritation:** Rabbit: Mildly irritating **Skin Irritation:** Rabbit: Slightly irritating

Skin Sensitization: Not a contact sensitizer in guinea pigs following repeated skin exposure.

**Subchronic (Target Organ) Effects:** Repeated overexposure to imidacloprid, may effect heart, thyroid, blood chemistry, and liver.

**Carcinogenicity / Chronic Health Effects:** Prolonged overexposure to imidacloprid can cause effects to the thyroid. Imidacloprid did not cause cancer in laboratory animal studies. The U.S. EPA has given imidacloprid a Group E classification (evidence of non-carcinogenicity in humans).

**Reproductive Toxicity:** In a two-generation reproduction study in rats, imidacloprid produced reduced mean body weights and body weight gains. No other reproductive effects were observed.

**Developmental Toxicity:** Rat and rabbit studies on imidacloprid resulted in skeletal abnormalities, increased resorptions (rabbits) and reduced body weight gains at doses that were also toxic to mother animals.

**Genotoxicity:** The imidacloprid mutagenicity studies, taken collectively, demonstrate that imidacloprid is not genotoxic or mutagenic.

Assessment Carcinogenicity: None listed with ACGIH, IARC, NTP or OSHA.

## **Environmental Fate:**

Hydrolysis half-life of imidacloprid is greater than 30 days at pH 7 and 25°C. The aqueous photolysis half-life is less than 3 hours. The soil surface photolysis of imidacloprid has a half-life of 39 days, and in soil, the half-life ranged from 26 to 229 days.
