Annual Report for Fiscal 2011

Dear Friends of Save Georgia's Hemlocks:

Our focus for 2011 was on increasing awareness of the hemlock problem, building momentum for the cause within the community, and providing practical information and hands-on help to save hemlocks. The significant results that were achieved are a clear testimony to the dedication, hard work, and support of our Board Members and Officers, Facilitators, members, and hundreds of other volunteers. With gratitude for an extremely productive year, we are pleased to present our 2011 Annual Report and invite your continued interest, involvement, and support in 2012.

Building on a Solid Foundation

SGH began 2011 with a reaffirmation of our mission, vision, and goals to ensure clarity of purpose and a review of our capabilities to deliver programs to all north Georgia counties where hemlocks are threatened.

<u>Mission</u>: Save Georgia's Hemlocks is a 100% volunteer non-profit organization of concerned citizens dedicated to saving endangered hemlocks through education and charitable service.

<u>Vision</u>: Through our efforts of preservation, conservation and restoration, there will be a healthy population of hemlocks in Georgia for future generations.

Goals: Our goals are to:

- **Educate** Enhance public awareness of the hemlock woolly adelgid crisis, current practical options, and emerging control technologies;
- **Enable** Ensure easy access to hemlock information, advice regarding economical solutions and direct assistance to property owners; and

• **Encourage** – Establish understanding of the aesthetic, economic and environmental reasons for property owners to take timely and effective action to save their hemlocks.

Delivering Vital Services

As the condition of infested hemlocks worsened and the economy remained troubled, SGH saw a heightened sense of alarm and greater demand from property owners and others for information and practical help to save their trees. Thanks to the efforts of our many dedicated volunteers who responded to these needs, we were able to:

- Deliver the Hemlock Help Program in 9 counties,
- Present the hemlock message to 1,600+ people,
- Increase our Facilitator corps to 97 volunteers,
- Provide direct help through the Hemlock Help Line to almost 800 individuals and groups,
- Conduct 9 charitable service projects, and
- Give away 1200+ hemlock seedlings.

Highlights of the year included our Annual Meeting at Smithgall Woods, the Hike and Help for the Hemlocks in partnership with our good friends in the Benton MacKaye Trail Association, and a large service project with the Boy Scouts to save more than 550 hemlocks at Foxfire Heritage Center and Museum. Managing Resources Responsibly

Through the generosity of our growing membership, friends, and other nonprofits and our careful use of their gifts, we were able to devote 90% of our spending to educational and charitable service programs. These included Hemlock Help Clinics, Facilitator training workshops, mailing 2,000 awareness post cards, and presentations to schools, property owners associations, and other community groups. We also saved 1,220 trees through charitable treatment projects, helped start a hemlock growing operation with 540 trees, and mentored several other nonprofits with similar missions. We are very grateful to all those who have supported our work.

Planning for the Future

Following the recent mild winter, adelgids have out come earlier than ever and are continuing their spread, putting hemlocks in even more danger. Increased awareness and timely action will be key in 2012. Here are the highlights of our strategic plan to address these challenges:

- Extending our program into 2 more counties
- Conducting more Clinics and other presentations
- Training more volunteer Facilitators
- Expanding our scope and capacity for hemlock treatment and planting projects
- Increasing our outreach to schools, property owners associations, and other community groups

- Hemlock Lessons taught for 350 children in12 elementary and middle school classes; 2 included hemlock sapling planting on campus and 6 included seedling potting.

- Hemlock information booth, seedling potting, and/or presentation at 7 festivals; donated saplings and educational materials for 2 more festivals
- 5 newspaper articles published; 1 newspaper interview
