**Date:** Saturday, November 9, 2019

Where to Meet: Buz Stone's workshop, 9612 Old 441 S, Lakemont, GA 30552.

**Driving:** From Fellowship Christian School in Roswell to Buz Stone's workshop is 89.7 miles.

Driving time is estimated to be 1 hr and 50 min. Note: 4-wheel drive is recommended between

Buz's workshop and the digging site, so please bring 4-wheel is you have it.

**Schedule: 10:00 a.m.** – Gather at Buz's workshop to receive project overview, safety reminders, and

instructions for the day.

10:15 a.m. – Caravan from Buz's workshop to the project location: the cabin of Bill & Betsy

Verner, 573 Taylor Creek Rd, Lakemont, GA 30552 (about 7 minutes). See driving directions attached

10:30 a.m. – Volunteers will set up the potting stations, then divide into small teams (each of which will include an experienced SCH Escilitator or other adult), begin rescuing saplings from

12:30 p.m. – Teams will come together at the cabin for a group picnic. After lunch we'll

resume work.

**By 3:00 p.m.** – Our target project completion time is 3:00 p.m.(or earlier if finished). We'll stop

work, clean the tools, load the potted saplings into Buz's trailer for transport back to his work-

shop, and then head for home.

**Terrain:** The terrain around the cabin is flat to gently rolling. We'll make sure everyone is assigned to a

work site where they can be safe and comfortable.

What to Wear: Dress for the weather (it may be chilly) and the activity, including long pants and long sleeves,

sturdy footgear with socks, and rain gear in case of light rain. We'll provide work gloves for

everyone.

What to Bring: We'll be digging, so bring pointed shovels / spades marked with your name. Pack a sack lunch,

personal water bottle and a camera if you like. We'll provide some snacks and extra bottled

water. If you have any serious allergies (like bee stings), bring whatever you need to manage.

**Don't Bring:** This is an environmentally-friendly, pack-it-in pack-it-out event, so please don't bring any glass

or Styrofoam items. Also, as much as we love dogs, please don't bring them this time.
